**Specification:**

The setup should consists of the following components:

**A. Stainless steel tank**

- 2 meter length, 1.2 meter height and 0.5 meter width (excluding the thickness of frames)
- Front long side should be transparent
- One short side (right) is detachable. Detachable side should be fastened with stainless steel bolts
- Tank should have adequate supports for sensor connectors and data logger
- Frame of tank made with stainless steel angle with sufficient number of holes or similar arrangements for holding LVDT's and other connectors
- Stand for LVDT and camera should be integrated with the tank
- Tank Support should be steel support frame of 60 cm height/Tank should be supported with suitable wheel arrangement for portability
- Base of the tank should extend to an extra 30 cm (other than specified dimension)
- Base should be provided with suitable drainage pipe/arrangements near the detachable side

**B. Reservoir for water supply**

- The capacity of the reservoir for water supply should be 500L

**C. Rainfall simulator system:** Connection pipes used for the rainfall simulator system should be fitted so as to avoid any kind of sagging or pressure loss during conveyance. It should include the following components:

**i. Collection unit or tank for collecting discharge**

- The capacity for the collecting tank should be of 50L

**ii. Pressure pump**

- It should have a flow Rate of 22 Liter per minute with a maximum pressure of 1 bar
- It should have a main control valve and pressure gauge near the pump outlet
- It should have a digital flow meter at the pump outlet with a flow range of 2 to 45 Liter/minute with a maximum hydraulic pressure of  $\leq 1.75$  MPa
- Power Rating Single Phase : 0.37 to 1.1 kW (0.5 to 1.5 HP)

**iii. Spray nozzles:**

- Nozzle (full cone spray nozzle) assembly should be supported by horizontal and vertical metallic frame adjustable (sliding) in width and length (min to tank size) with attaching rods with slots along the length to adjust nozzle height
- Nozzle should be fixed with control valve and pressure gauge excluding main control valve and pressure gauge near the pump outlet



- Simulator should have tilting and adjustable facility (Adjustable nozzle height). The height can vary up to 5 m
- Nozzle should be of material suitable for resisting abrasion, erosion and corrosion.
- Capacity of nozzle to simulate rainfall should be in the range of 0.1 mm/hour to 250 mm/hour
- Nozzle attachment fixtures should be like that so as to accommodate another type of nozzle also.
- Drop size distribution should be uniform for the entire study
- Size of drops generated by nozzle should be nearly same as of natural rainstorms.
- Spray Angle should not be less than 60 degrees. Spray distance up to 4m.
- Single nozzle should have a flow rate of 12 ml/min to 840 ml/min and a maximum pressure of 10 psi. Number of nozzles should be selected based on providing the rainfall in the entire area of test tank in the range of intensities of 0.1 mm/hour to 250 mm/hour.
- Connecting pipes should be of best quality (wear and tear free, corrosion free) sufficient length to accommodate with the variable simulator frame size with sufficient supports.
