He / She shall be responsible for monitoring the target fixed by the Department for successful completion of the project with due consideration for the quality and economy following the norms and standards laid down in Designs, Drawings and Contracts. b. Reporting any justifiable and unjustifiable delay cost overruns in any activity specified in the contract document of construction and Architect. c. Coordinating with various stakeholders including CPWD/PMC, Architect, Contractors, Structural / MEP / HVAC / Firefighting / Lift Consultants etc of the project via SMS / emails to remind and follow-up each activity with respect to delivery of drawing, quality, cost schedule, time schedule and corrective actions etc. d. To prepare presentations, progress report, updating time schedule, physical / financial progress, delays, overruns, non-conformity, suggesting and monitoring the frequency of various quality control tests, exercise and other bottlenecks, agenda and minutes for review meetings with various stockholders of the project e. He/ She shall witness and report the commissioning of each component in the building according to the approved drawings and specifications before issue of Completion Certificate by CPWD/PMC. f. Coordinating with local bodies, Fire & Rescue Department, Pollution Control Board, KSEB for obtaining approval. g. He / She shall be reporting to the Chairman (EWD) on a day-to-day basis h. He / She shall be responsible for record keeping and handing over to all the documents pertaining to the project on completion to EWD.
