Such action will result in the rejection of bid, in addition to other punitive measures.</p> <p>c) Each bidder shall submit only one bid, either by himself or as a partner in a joint venture or as a member of the consortium. 1. Scope of work:

The proposed Single Point Laser Doppler Vibrometer should measure the vibration on various structures made of different materials such as Membranes, Delicate structures etc

4. The manufacturer should provide necessary hardware and Data should be transferable through one or more of the industrial grade communication protocols like I2C, Ethernet, RS232, USB, etc.
5. Laboratory site requirements (if any) to install the product(s) must be provided.
6. The LDV should be warranted for a standard period of 1 year.
7. Lead time of delivery of LDV must be in 10 to 12 weeks, upon finalization of the order.
