Applications are invited for **Post Doctoral Positions** in the areas of Civil Engineering, Computer Science and Engineering, Electrical Engineering, Mechanical Engineering, Chemistry, Mathematics, Physics & Humanities and Social Sciences. Guidelines are given below.

Note that a postdoctoral fellow need to identify a faculty member with whom he/she would like to be associated. The application should be submitted ONLY AFTER you have identified the mentorand obtained his/her consent.

Post Doctoral Fellowship at IIT Palakkad (Guidelines)

ELIGIBILITY

- 1. Holders of Doctoral degree from any recognized Institute/University are eligible to apply *within five years of getting their doctoral degree*. Maximum Age shall be **35 years** at the time of applying (relaxation as per GOI rules will be given for women/SC/ST/PwD/OBC candidates)
- 2. Ph.D. students, who have submitted their thesis, also are eligible to apply. However, they have to submit the provisional/degree certificate within 6 months from the date of appointment as an Institute Post Doctoral Fellowship (PDF). If it is not submitted within the time limit, the appointment will stand cancelled or a decision will be taken in consultation with the thesis processing authority.
- 3. Normally, IITPKD Ph.D. scholars are not encouraged to apply for Institute PDF. However, outstanding candidates can apply.
- 4. The Application format and other relevant details are attached as Annexure.
- 5. The candidate will have to identify a mentor in the Institute, get in contact with the mentor, and get his/her consent.
- 6. The mentor will have to send a confidential letter of recommendation to the Dean R&D.

Institute Selection Committee (ISC): CONSTITUTION AND TERMS OF REFERENCE

7. Institute Selection Committee for Institute PDF:

 From Research Advisory Committee - One Member (RAC) A faculty member nominated by the Dean, R&D from the concerned Discipline. It will be the HoD, if thre is an HoD. 8. The Dean R&D will constitute the committee and get the approval of the Chairman, Senate.

- 9. The Chairman-ISC will convene the meeting of the Committee as and when required and send specific recommendation to the Chairman, Senate with respect to the applications.
- 10. The Chairman-ISC is **authorized to invite any faculty member** as special invitee.
- 11. The mentor shall not be nominated/invited as a member of the selection committee

APPLICATION PROCESSING & INTERVIEW

12.For every discipline a Standing Committee will be formed to process the postdoctoral applications (PDFC).

13. The **application** will be submitted to the Dean R&D by the applicant. The Dean will send it to the Department The application will be sent back to the Dean with the recommendation from the PDFC. If the recommendation is to consider the applicant for the fellowship, Dean will constitute ISC which will look at the application.

14. If ISC recommends the application for further consideration, the interview call letter will be sent by the Dean R&D.

15. Candidates called for interviews are **eligible for reimbursement of to and fro III AC** train fare by shortest route.

SELECTION & OFFER:

16. The application can be submitted at any time of the year.

DURATION AND JOINING

17. The **duration** of the fellowship will be initially for a period of 2 years, extendable for a further period of one more year based on the progress of the PDF and the recommendation of the Department.

ASSIGNMENTS

18. Apart from quality research work, post-docs will also be encouraged to write funding proposals. They will not be engaged in teaching in general, unless the PDF himself/herself wishes so.

19. The post doc will be attached to the mentor only for administrative purposes. He/She will work 'with' the mentor rather than 'under' the mentor. He/She will have independence to change the course of research in consultation with Performance Assessment Committee (PAC) (see below for details of PAC).

20. Post docs will be eligible to serve as co-guide for B.Tech and M.S. projects along with the mentor. In such cases the guidance will automatically end when the PDF leaves the institute.

BENEFITS

21. The PDFs are eligible for the following :

•	Fellowship Amount	:	Between Rs.45,000-55,000/- consolidated (depending upon experience and qualification)
•	Accommodation	:	Suitable Hostel / Campus accommodation as per IIT norms will be provided if requested and if available
•	House Rent Allowance (HRA)	:	For married Institute Post-Doctoral Fellow, if they are not provided accommodation within the campus, they are eligible for HRA as per rules.
•	Contingency Grant	:	A contingency grant of Rs.1,00,000/- per annum will be provided to the Post-Doctoral Fellow for research purposes.
:	Medical benefits / Insurance Permission for attending Conference	:	As applicable to Ph.D scholars Either National or International Conference can be permitted provided funds are available in the contingency grant of the concerned doctoral fellow.
•	TA Claim for joining	:	Train fare by II AC from place of residence to IIT Palakkad (by shortest route).

 Leave
 Upto 30 days of leave with fellowship in a year. The leave can be availed on a pro rata basis for the duration (on a 6 months' basis) of the Fellowship completed.

PERFORMANCE ASSESSMENT COMMITTEE (PAC) :

22. The performance of the Post-Doctoral Fellow will be assessed by the **Performance Assessment Committee (PAC)** with the following composition :

The PAC will meet at the end of first year, and then every six months.

PROGRESS REPORT

23. The candidate should present a **progress report to PAC** detailing the research work carried out and research findings supported by reprints/preprints/manuscripts of the papers published/accepted for publication or communicated/ research reports for this purpose.

TERMINATION

24. If the Post-Doctoral Fellow wishes to leave the program before the end of the tenure, he/she can do so with prior approval of the PAC giving one month's notice.

25. The fellowship may be **terminated** by the Institute if the performance /conduct of the fellow is found unsatisfactory by the PAC. For termination, one month's notice will be given to the PDF.

26. It can also be terminated if the PDF engages in any unethical practices like plaigarism or other scientific misconduct.

INTELLECTUAL PROPERTY RIGHTS

27. On all IPR related matters the rules applicable to the regular faculty members of the Institute will

apply.

28. In addition to fellowships offered by IITPKD, candidates who have been offered PDF by other agencies, like SERB, NBHM etc. also can apply. It is not necessary for them to appear for an interview. If they join, they will be governed by the regulations of the grant giving organization, and by those of IIT Palakkad, in cases where the grant giving organization has not specified the regulation.
